1- Minutes of Meeting of 104th State Level Appraisal Committee (SLAC) for Housing for All held on 21.03.2023.

Detail Project Report under "Housing for All" has been appraised by the State Level Appraisal Committee (SLAC). After discussion, SLAC has appraised the DPR put up by the State Level Nodal Agency and recommends the approval with following suggestions:-

1. Summary of 77 ULBs comprising 49,698 Beneficiaries under Beneficiary Led Construction – New, where consent letter and land documents was received are given below: -

This lot of DPR contains total number of 77 ULBs spreading across the state. These ULBs have been segregated in two groups as per their location falling under the earth quake prone Zone III and Zone IV.

The cost of the construction may be reduced of those ULBs which falls under zone III. The safety measures can be taken in Zone IV considering the nature of the soil falling under respective seismic zones. As explained in PMAY HFA guidelines (Chapter 9), that different layout designs will be prepared to construct the building with innovative technologies and materials, green buildings using natural resources.

The table below shows the breakup of the DUs according to the seismic zone.

The Total Project cost of 41 DPR under Zone IV is Rs. 1,06,678.225 Lakh, Central Share is Rs. 42,053.50 Lakh, State Share is Rs. 28,049.00 Lakh and Beneficiary Share is Rs. 36,575.725 Lakh.

SLAC recommendation:-

- SLAC recommends the approval of 77 DPRs comprising 49,698 validated Beneficiaries of BLC(N) to SLSMC for onward submission of GoI. The total project cost of these DPRs is Rs. 1,79,374.591 Lakh, Central Share is Rs. 74,527.00 Lakh, State Share is Rs. 49,698.00 Lakh and Beneficiary Share is Rs. 55,149.591 Lakh.
- 2. Copy of DM Certificate regarding beneficiary validation should be enclosed with each DPR for record purpose.
- The Committee examined the DPR and it was found that only model drawings have been provided in the DPR.
 The DPRs for new projects are prepared by the PMAY(U) DPR/PMC consultant of SUDA, the Committee
 referred to the scope of work mentioned in section-5 of the agreement with DPR/PMC consultants. The scope of



ty of

work for DPR preparation states that "Preparation of Beneficiaries wise detailed Architectural/Engineering designs, drawings & Estimates for all sizes of plots" is to be done by the consultant. Also, the scope of work for PMC states that "PMC will supervise the construction work to ensure adherence to the drawings, prescribed high standards of quality and timely completion of the project and verify and certify the progress of the work." In view of the above, the committee recommended that the implementation of both the above points should be ensured by the concerned Project Officer, DUDA through DPR/PMC consultants.
